

GIFT FOR MOM OFFICIAL RULES

Promotional Period: May 12, 2024, 10AM – 10PM
(Tulalip Bingo & Slots opens at 11AM)

Prize Minimum: \$5 Free Play
Prize Maximum: \$1,000 Free Play

- 1. To be eligible for this promotion, the player (hereafter "player" or "players") must be a current ONE club member in good standing.
- 2. New members are qualified for this promotion upon valid enrollment.
- 3. Promotion will be available at any Tulalip Resort Casino, Quil Ceda Creek Casino or Tulalip Bingo & Slots promotional kiosk.
- 4. Players are limited to one (1) participation. When participation is redeemed at one (1) property, it will not be available for the player at any other property.
- 5. This promotion will be available on Sunday, May 12, 2024, from 10AM to 10PM at Tulalip Resort Casino and Quil Ceda Creek Casino. This promotion will also be available at Tulalip Bingo & Slots on Sunday, May 12, 2024, from 11AM to 10PM.
- 6. Any female player will automatically qualify to play the kiosk game. Player must visit a ONE club promotional kiosk and:
 - a. Swipe players ONE club card.
 - b. Select the Promotions tile.
 - c. Enter a valid PIN.
 - d. Select the Mother's Day tile.
 - e. Follow game prompts.
- 7. If a player is awarded Free Play, the player is responsible for activating Free Play within four (4) hours of award at the kiosk.
- 8. Any Free Play that is not activated within the allotted activation period, or expired, will not be reissued.
- 9. Free Play credits must be used at a slot machine; cash-out option is not available for this promotion.
- 10. Promo Free Play credits under \$250 will expire twenty-four (24) hours after prize activation. Promo Free Play credits over \$250 will expire thirty (30) days from prize activation.
