Official Rules

Promotional Period: March 1, 2023, at 8AM – March 29, 2023, at 10PM

Redemption Dates: Every Wednesday in March from 10AM – 10PM

Prize Minimum: \$5 Free Play **Prize Maximum:** \$1,000 Cash

1. To be eligible for this promotion, player (hereafter “player” or “players”) must be a current ONE club member in good standing.
2. New members are qualified for this promotion upon valid enrollment.
3. This promotion is available at Quil Ceda Creek Casino.
4. This promotion will occur on Wednesdays; March 1, 8, 15, 22 and 29, 2023.
5. A player is responsible for using their ONE club card during rated slot play to earn points on promotional Wednesdays from 8AM to 10PM.
6. To qualify for this promotion, a player must earn 200 promo slot points on their ONE club card.
7. A player is limited to three (3) participations per promotional day.
8. Participations are awarded at 200 points, 800 points and 2,000 points.
9. Once a player meets qualifications, player must visit a ONE club promotion kiosk and:
 - Swipe their ONE club card
 - Select promotion
 - Enter valid pin
 - Select promotional tile
 - Follow play prompt
10. It is the responsibility of player to use their card. Participations will not be awarded for play not recorded.
11. At each participation, the player will receive a Free Play or cash prize.
12. Cash prizes available are \$1,000 and \$500 weekly. Cash prizes are awarded randomly throughout the promotion.
13. All cash prizes awarded at the kiosk will print a receipt.
14. All prize receipts must be redeemed at ONE club by the expiration date and time on the receipt.
15. All Free Play prizes awarded will be attached to the player’s account and must be activated by a card swipe at any slot machine within four (4) hours from kiosk award.
16. All Free Play prizes will expire twenty-four (24) hours from activation.

17. Any Free Play prize that is not activated within the allotted activation period, or expired, will not be reissued.
18. Any player found to be abusing the promotion rules or tampering with the promotion in any way may be disqualified and declared ineligible.
19. Management reserves the right to modify or terminate this promotion at any time at their sole discretion with or without notice, subject to Tulalip Tribal Gaming Agency approval. All rulings made by event management during the promotion are final.
20. All winners must have a valid government issued photo identification to claim their prize and may be required to fill out a W-9, 1099 or 1042S. Foreign players are subject to additional taxes, based on federal regulations. Failure to agree with these terms will result in forfeiture if the prize.
21. Any prize awarded due to a system, screen or printing error will become void and will not be paid out. All rulings made by management are final.
22. Qualification, participation, and redemption requirements for this promotion are limited to Quil Ceda Creek Casino.
23. Tulalip Gaming Organization and its affiliates are not responsible for the kiosk being unavailable due to system malfunction and can deny any payout due to kiosk malfunction.
24. All prizes are subject to regulatory approval.
25. Select vendors and players who are currently expelled from Tulalip Gaming Organization properties are not eligible to participate in casino promotions.
