



## HALLOWEEN COSTUME DRAWING OFFICIAL RULES

**Promotion Date:** Saturday, October 30 from 8PM – 11PM

**Prize Minimum:** \$250 Cash    **Prize Maximum:** \$2,000 Cash

1. To be eligible for this promotion, player (hereafter “player” or “players”) must be a current ONE club member in good standing.
2. New members are qualified for this promotion upon valid enrollment.
3. This promotion will occur on Saturday, October 30, from 8PM – 11PM.
4. Players must be wearing a costume to be eligible. A jersey or sports shirt will not qualify as a costume. A marketing team member will make final decision if attire qualifies as a costume.
5. Quil Ceda Creek Casino reserves the right to disqualify any entry that does not qualify or that is not considered appropriate. No entry may contain defamatory content, including but not limited to, images, words or symbols that are widely viewed as offensive to persons of a certain ethnic, religious, racial, sexual-oriented or socioeconomic group, as determined at the casinos’ sole discretion.
6. Costume drawing entries will be accepted from 8PM – 10:30PM.
7. Player is limited to one (1) entry.
8. Halloween masks will be allowed to be worn only at the promotional table, not on the gaming floor.
9. No weapons, real or fake, will be allowed.
10. Players must visit a ONE club promotional kiosk and print a participation ticket:
  - a. Swipe player’s ONE club card
  - b. Select Promotions tile
  - c. Enter valid PIN
  - d. Select Promotional tile
  - e. Follow prompts
11. Upon selecting promotional tile, a receipt will print and must be taken to the promotional table to qualify.
12. At 11PM, fifteen (15) winners will be drawn to win cash prizes.
13. Prizes as follows:
  - 1<sup>st</sup> place = \$2,000
  - 2<sup>nd</sup> place = \$1,000
  - 3<sup>rd</sup> place = \$750
  - 4<sup>th</sup> place = \$500
