



## PICK YOUR GIFT GIVEAWAY

### Official Rules

**Redemption Dates:** March 7, 14, 21 and 28, 2024

**Redemption Times:** 8AM -10PM at any QCC Promotional Kiosk

### HOW TO QUALIFY

1. To be eligible for this promotion, player (hereafter “player” or “players”) must be a current ONE club member in good standing.
2. New members are qualified for this promotion upon valid enrollment.
3. To qualify for this promotion, a guest must earn 300 promo slot points at Quil Ceda Creek Casino from 8AM – 10PM each promotional Thursday.
4. Guests who prequalify will receive a mailer via postal mail or email containing promotional instructions.
5. Prequalification is determined by a player’s recorded ONE club card activity at Quil Ceda Creek Casino during a set time frame and specific player demographics.

### PROMOTION

1. Each qualified guest is responsible for claiming the redemption code receipt each promotional day.
2. This offer is nontransferable and must be redeemed in-person by the player listed on the gift receipt.
3. To redeem, a guest must visit a Quil Ceda Creek Casino promotional kiosk and choose one of the following options:
  - **Gift** - Upon selecting this option, the kiosk will print a gift receipt which will contain the redeeming guest’s information and a redemption code. To receive the gift, the guest must visit the vendor website, select a gift from the options available and provide their shipping address. Gifts will be shipped to the guest by the vendor.
  - **Free Play** – Upon selecting this option, the guest chooses to redeem the Free Play offered at the time of redemption. After redeeming at the kiosk, a player must activate their Free Play within four (4) hours of award at any Quil Ceda Creek Casino slot machine.
4. Once a selection of the gift or Free Play has been made, it cannot be changed.
5. It is the guest’s responsibility to visit the website: [redeem.snappygifts.com/casino](https://redeem.snappygifts.com/casino) by the expiration date listed on the gift receipt.

6. Quil Ceda Creek Casino is not responsible for lost or stolen gift receipts.
7. Gifts cannot be shipped to Quil Ceda Creek for later pick-up.
8. If a redemption code receipt does not print, the guest will need to visit the ONE club to have one reprinted.
9. Activated Free Play will expire within 24 hours of activation. Any expired free Play will not be reissued.
10. All selections are final and will not be adjusted.
11. At the time of online redemption, the promotional gift vendor is responsible for shipping the guest's gift selection to the address provided by the player. 12. Qualification, participation, and redemption requirements for this promotion are limited to Quil Ceda Creek Casino.
